Summary of player's evidence			
The Player denies foul play. At the hearing he stated he was attempting to tackle and rip off the ball from the carrier. It wasn't illegal in any way and it wasn't a dangerous tackle even though his position was upright. He had no intention to hurt his opponent. There was no head contact with the opponent as it can be seen from the other angle/camera footage. The player admitted, there was a possible contact with the opponent's eye, but it was accidental.			
Findings of fact			
From the video footage it is clear that the way the Player went into contact with his opponent was high but there was no head contact at all. It can be seen only from the camera 90° from the referee perspective. From the camera as seen by the referee, the head contact was almost certain. It is also very likely that there was a contact made by the right hand of the Spanish #5 with an eye area of the opponent, but I find this action purely accidental, not a foul play. After reviewing videos, I was satisfied no head contact accured. That is why the onfield decission has been overturned. Red card has been rescinded and removed from players record.
